VN-Index increased for the 6th consecutive session

Market outlook:

Stock market: The market struggled in the range of 1,230 - 1,240 all day before rebounding at the end of the session and closing at 1,245.5, up nearly 11 points compared to yesterday, along with improved liquidity. Market breadth tilted to the positive side with 18/18 sectors increasing, of which the Basic resources led the increase, followed by the Financial services. Regarding foreign transactions, today they net sold on the HSX and net bought on the HNX. VN-Index may experience struggling in the coming sessions when it touches to the old resistance levels, however, the index is showing the possibility of returning back to 1,280 threshold.

Future contracts: Futures contracts increased according to the movement of VN30. Investors are recommended to be cautious in the coming sessions.

Covered warrants: In the trading session on September 6, 2023, warrants fluctuated according to the increasing momentum of the underlying stock.

Highlights:

- VN-Index **+10.52** points, closing at **1245.5**. HNX-Index **+3.08** points, closing at **255.36**.
- Pulling the index up: **HPG (+1.75)**, **VPB (+1.35)**, **GAS (+0.91)**, **FPT (+0.7)**, **VHM (+0.65)**.
- Pulling the index down: **VIC (-0.67)**, **BID (-0.25)**, **HVN (-0.08)**, **VSH (-0.06)**, **VNM (-0.05)**.
- The matched value of VN-Index reached VND **23,699** billion, increased **8.77%** compared to the previous session. The total transaction value reached VND 1,131,935 billion.
- The trading range is 15.61 points. The market had **356** advancers, 70 reference stocks, **145** decliners.
- Foreign investors' net selling value: VND **-102.17** billion on HOSE, including **HDG (-85.09 billion)**, **SSI (-50.06 billion)**, **FUEVFNVD (-49.61 billion)**. Foreign investors were net buyers on HNX with the value of VND **13.11** billion.

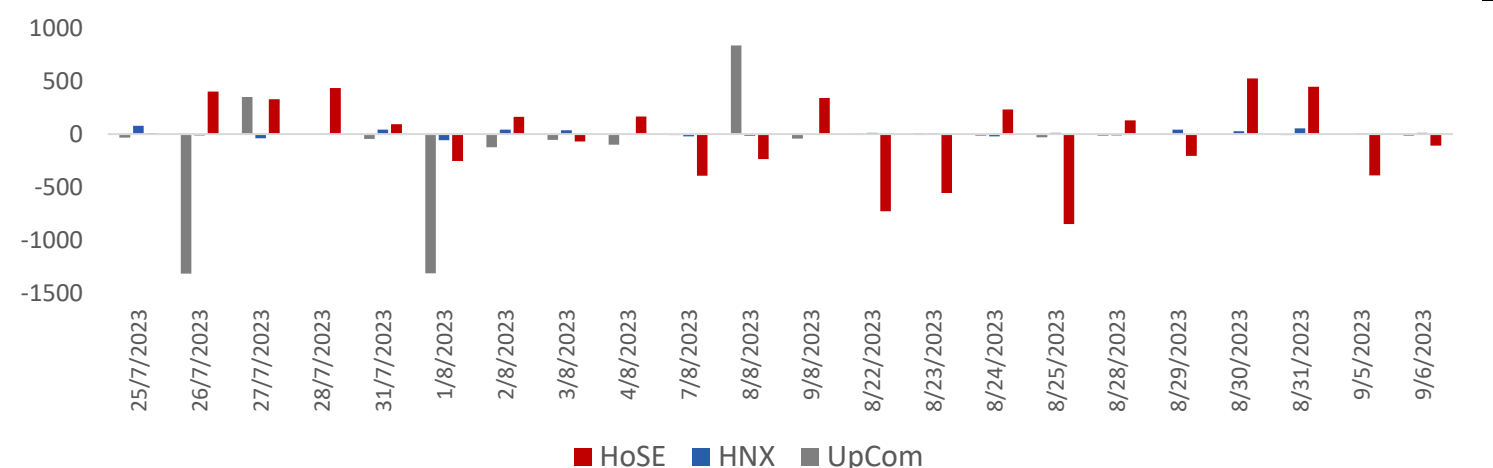

Foreign transaction

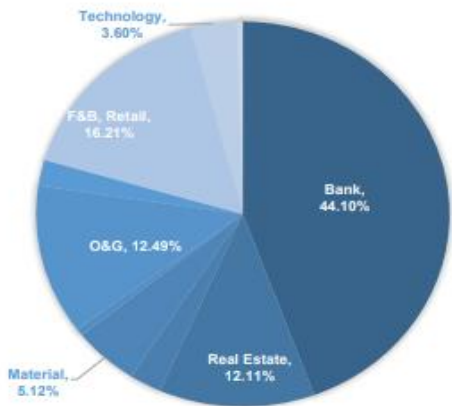

The BSC50 listing is suitable for bull market periods and has potential for investors looking for short-term trading opportunities.
