STOCK MARKET

VN-Index moved up to 1,285 in the early morning session, but selling force here pushed the index down to 1,250 before the index went up to close at 1,261.93 points, down more than 19 points compared to yesterday's session. Market breadth tilted to the negative side with 16/18 sectors decreasing, of which the Information Technology led the decline, followed by the Financial Services. On the contrary, the two sectors that maintained the green color today were Chemicals and Petroleum. Bottom-fishing force has appeared at the 1,250 threshold, but it cannot be ruled out that the market will continue to fall back to this threshold in the short term. Today's decreasing session has a sudden increase in liquidity compared to previous sessions, so

During the trading session on 24/05/2024, warrants fluctuated according to the correction of the underlying stocks.

HIGHLIGHT

- VN-Index -19.10 points, closing at 1261.93 points. HNX-Index -5.19 points, closing at 241.72 points.
- Pulling the index up: GVR (+0.87), ACB (+0.80), HVN (+0.28), PLX (+0.23), LPB (+0.13).
- Pulling the index down: FPT (-1.70), VCB (-1.11), CTG (-0.98), VPB (-0.96), HPG (-0.85).
- The matched trade value of VN-Index reached VND 32,350 billion, increased 55.22% compared to the previous session. The total transaction value reached VND 35,468 billion.
- The trading range is 34.79 points. The market had 9 gainers, 43 remaining unchanged, 364 losers.
- Foreign investors' net selling value: VND -1531.80 billion on HOSE, including FPT (VND -355.37 billion), MWG (VND -131.92 billion), MBB (VND -113.01 billion), VHM (VND -101.79 billion), SSI (VND -99.27 billion). Foreign investors were net buyers on HNX with the value of VND 24.65 billion.
