

STOCK MARKET

The VN-Index closed today down nearly 10 points after failing to surpass the 1,265 threshold. Market breadth tilted to the negative side with 16/18 industries decreasing, of which the Personal & Household Goods industry led the decline, followed by Chemicals, Tourism and Entertainment,... Regarding foreign transactions, today this block continued to net sell on the HSX exchange. In the coming week, VN-Index needs the support of cash flow to confirm a clearer trend.

FUTURES CONTRACTS

Futures contracts all decreased according to the movement of VN30.

COVERED WARRANTS

During the trading session on 01/11/2024, warrants fluctuated according to the recovery of the underlying stocks.

- VN-Index **-9.59** points, closing at **1254.89** points. HNX-Index **-0.95** points, closing at **225.41** points.
- Pulling the index up: **SSB (+0.28)**, **BVH (+0.11)**, **NLG (+0.08)**, **BCG (+0.07)**, **SCS (+0.06)**.
- Pulling the index down: **MSN (-0.72)**, **GVR (-0.57)**, **VPB (-0.57)**, **MBB (-0.57)**, **HPG (-0.54)**.
- The matched trade value of VN-Index reached VND **13,564** billion, increased **24.03%** compared to the previous session. The total transaction value reached VND 14,767 billion.
- The trading range is 10.34 points. The market had **86** gainers, 60 remaining unchanged, **289** losers.
- Foreign investors' net selling value: VND **-301.72** billion on HOSE, including **MSN (VND -253.20 billion)**, **VHM (VND -164.62 billion)**, **KDC (VND -101.13 billion)**, **FPT (VND -50.85 billion)**, **NLG (VND -40.02 billion)**. Foreign investors were net buyers on HNX with the value of VND **4.28** billion.

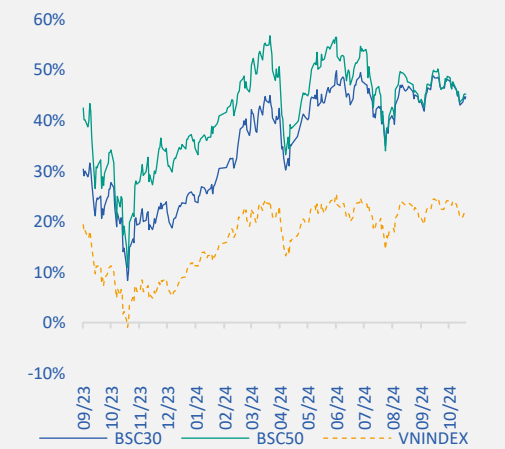

Performances of BSC30, BSC50



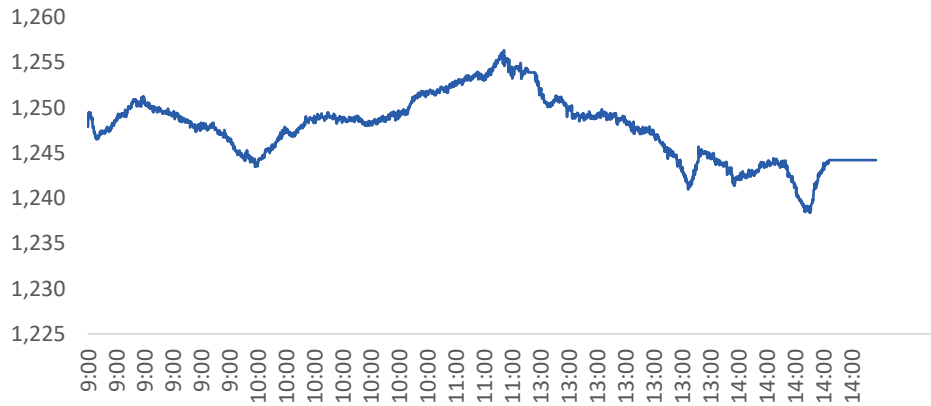

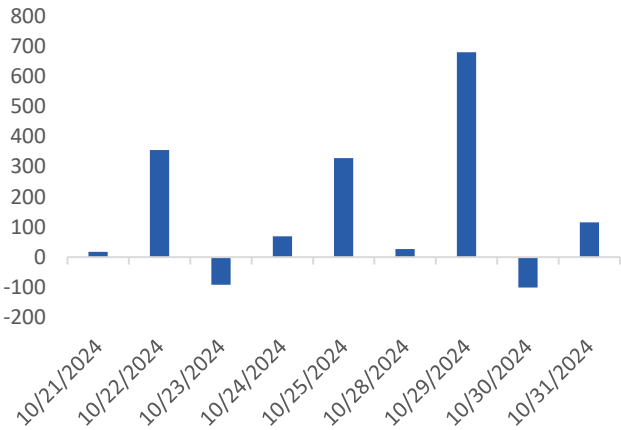

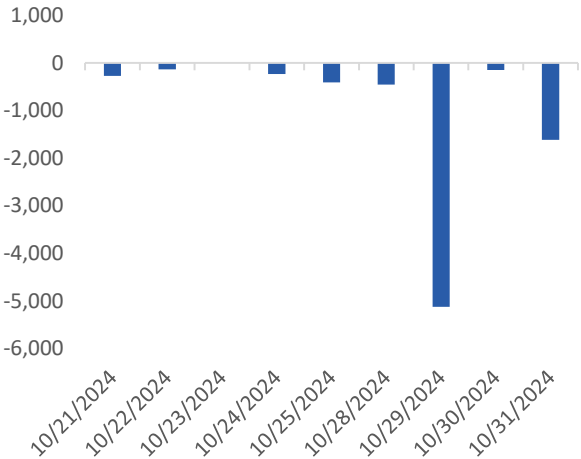
