



THE VN-INDEX CONTINUES TO OSCILLATE AT HIGH PRICE LEVELS

Monday, 17 February 2025

STOCK MARKET

The VN-Index continued to trade around the 1,275 level today, closing at 1,272.72 points, nearly unchanged compared to the previous session. Market breadth was fairly balanced, with 9 out of 18 sectors advancing. The Financial Services and Communications sectors led the gains, while the Retail and Insurance sectors experienced the most significant declines. Regarding foreign trading activity, foreign investors were net sellers on both the HSX and HNX exchanges today. In a positive scenario, the VN-Index could consolidate further in the 1,270–1,280 range in the short term before gaining momentum to push towards 1,300, although some volatility is to be expected.

FUTURES CONTRACTS

Futures contracts all decreased according to the movement of VN30.

COVERED WARRANTS

During the trading session on 17/02/2025, warrants fluctuated according to the struggling movement of the underlying stocks.

HIGHLIGHT

- VN-Index -3.36 points, closing at 1272.72 points. HNX-Index +1.97 points, closing at 233.19 points.
- Pulling the index up: GEE (+0.26), SSB (+0.24), VIX (+0.22), GVR (+0.19), SJS (+0.19).
- Pulling the index down: BID (-0.74), MSN (-0.57), CTG (-0.51), TCB (-0.50), FPT (-0.46).
- The matched trade value of VN-Index reached VND 15,391 billion, increased 10.73% compared to the previous session. The total transaction value reached VND 17,643 billion.
- The trading range is 5.77 points. The market had 195 gainers, 75 remaining unchanged, 266 losers.
- Foreign investors' net selling value: VND -601.19 billion on HOSE, including MWG (VND -161.92 billion), VNM (VND -100.77 billion), HDB (VND -72.88 billion), FPT (VND -70.85 billion), SSI (VND -45.44 billion). Foreign investors were net sellers on HNX with the value of VND -28.47 billion.







The BSC50 listing is suitable for bull market periods and has potential for investors looking for short-term trading opportunities.
