

# **STOCK MARKET**

The VN-Index continued to rise, gaining more than 13 points today to close at 1,415.46 points. Market breadth was positive, with 17 out of 18 sectors advancing, led by Basic Resources, followed by Financial Services, Real Estate, and others. Regarding foreign investors' trading activity, they continued to record net buying on the HSX, with a net inflow of VND 1.5 trillion today. In the upcoming sessions, the VN-Index is likely to maintain its upward momentum towards the 1,420 - 1,430 range.

#### **FUTURES CONTRACTS**

Futures contracts all increased according to the movement of VN30.

#### **COVERED WARRANTS**

During the trading session on 08/07/2025, warrants fluctuated according to the uptrend of the underlying stocks.

#### HIGHLIGHT

- VN-Index +13.40 points, closing at 1415.46 points. HNX-Index +1.78 points, closing at 237.68 points.
- Pulling the index up: VHM (+2.25), HPG (+1.70), VCB (+0.77), VJC (+0.66), GAS (+0.66).
- Pulling the index down: BVH (-0.10), TPB (-0.09), GEE (-0.07), VPI (-0.03), OCB (-0.03).
- The matched trade value of VN-Index reached VND 26,673 billion, increased 1.27% compared to the previous session. The total transaction value reached VND 28,389 billion.
- The trading range is 14.86 points. The market had 217 gainers, 58 remaining unchanged, 92 losers.
- Foreign investors' net buying value: VND 1512.19 billion on HOSE, including HPG (VND 669.29 billion), FPT (VND 345.84 billion), SSI (VND 274.24 billion), SHB (VND 158.99 billion), VIX (VND 153.41 billion). Foreign investors were net buyers on HNX with the value of VND 4.65 billion.




