





MARKET COMMENTARY

Market sentiment remains weak today when the VN-Index has once broken its 590 support and touched 588.6 pts. However, the positive headline on PMI as well as the foreigners' net purchases has partially supported the index remains 590 pts at the close. The narrow fluctuation and the unchanged liquidity today showed that the market was close to its new short-term balanced point. But we also note of some largest risks at the present are foreigners stop buying & bank stocks are around their resistance and showed signs of adjusting.

Short-term investors have taken profit under our recommendation in the last two reports can consider buying back if the VN-Index keeps above its 580 pts support.

MARKET PERFORMANCE

The VN-Index and HNX-Index slightly reduced when approaching their resistances. OGC share was active with 6.7 million traded shares and closed at its floor price. The other speculative stocks such as VHG, SHB, PVX and HUT only slightly decreased.

Banking stocks seem to be unchanged instead of deep falling as expectation of many investors. Specifically, VCB, ACB and STB ended at their reference prices while MBB, SHB, EIB and BID just dropped VND100 / share.

Foreign investors continued to be net buyers on both exchanges, their total net buying value reached over VND75 billion. Shares bought strongly were continually banking stocks (BID, CTG) and real estate stocks (VIC, HAG).

FOREIGN-INVESTOR PERFORMANCE

Foreign investors were net buyers on both HSX and HNX with values of, respectively, VND64.13 billion and VND12.51 billion.

Specifically, on HSX, foreigners bought strongly MWG (VND31.2 billion), CTG (VND13.7 billion) and BID (VND8.7 billion) while selling mainly HPG (VND18.4 billion) and NBB (VND12.6 billion).

On HNX, they bought significantly PVS (VND5.8 billion), SHB (VND3.5 billion) and SD5 (VND1.7 billion). On the selling side, they sold mostly SDT (VND1.4 billion).

MACRO ECONOMY

February PMI edged up 0.2 points at 51.7, slightly higher over last month (51.5), extending the increase in 18 consecutive months.

Production growth maintain positive during the past 1.5 years: Growth rate of new orders increased compared with that in the first month of the year. Input prices plummeted due to the downward trend of oil prices. Thus, Vietnam receive good news in the manufacturing sector in the first lunar month.

TECHNICAL ANALYSIS

The red candle as spinning top returned the lower support area around the level 590, the market lost the support 595 includes 4 sessions of the accumulation, improved liquidity, trading volume corresponding to 1.11 times the previous session.

Observe the changes in the session, the first rally cannot help the market above the reference, the VNindex quickly down this line and maintain support above the level 590 during the morning session and the first half of afternoon session. A correction made the market to check the support level 590, but the index has recovered quickly closed on this support, gaining 590.73 points, down 1.84 points respectively.


The MFI (14) has not really improved, realising 60, and reaching 60.3 points. The RSI (15) continued falling after hitting the line 70 from the previous week, gaining 59.81 points. The MACD (12.26) line tends to reverse, but this line remains on its slow signal indicator and while on the line Zero, a sell signal not yet appear.

The market stands on the support 590 reliably, the 595 become temporary resistance. In the next session, the market is likely to reexamine the support level 590 and cannot conquer quickly the resistance level of 595








Government Bond Yields 2 recent weeks

Reverse Repo Volume on OMO 2 recent weeks






