Weakening demand

BSC's Forecast on the stock market

Summary

First day of US President's visit brought some good news: US will lift arms embargo on Vietnam, \$11.3 Billion deal between Boeing and Vietjet. However, VN-Index (-0.61%) had fourth decline in a row on account of large-cap stocks fell, especially bank stocks and GAS. VCB (-2.7%) only pull VN-Index down 1.73 points. All markets' liquidity weakened significantly in morning session but was enhanced in the afternoon. HSS (+1.2%) had a noticeable put-through order with 12.05 mil stocks at ceiling price. Both HNX-Index (-0.58%) and Upcom- Index (-0.67%) fell slightly. Today, foreign investor bought net on 3 exchanges.

Recommendation

Market demand weakened but VN-Index has been moving in a safe area. Upward momentum has weakened significantly; hence, investors should continue to reduce proportion of holding if VN-Index falls below 608 points in the losing sessions or cannot pass 615 points in the rally sessions.

Market highlights

Foreigners were net buyers on the HOSE and on the HNX today. Market corrected near the support level 610 points and liquidity continued to weaken, with 197 advancers /208 decliners on both exchanges. Market liquidity is only really rose from early afternoon trading session, the majority of large-cap stocks decline, as GAS and banking group VCB BID, CTG and petroleum, applies to shares other industry group in the market. Rumor such as what's AGM of VNM led to profit-taking activities when there is official.

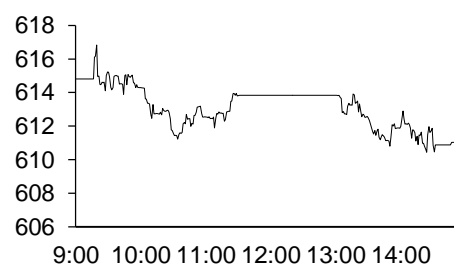
Recommendations

The market fell by -3.78 points, this is the fourth consecutive losing session due to trading activities of foreign net, gaining 611.03 points. Market demand weakened and the VN-Index has been moving in a safe area.

The uptrend has not confirmed the end, but market upward momentum has weakened markedly, and investors should continue to reduce the proportion of holdings when the VN-Index falls below 608 points in the losing sessions or cannot pass 615 points in the rally sessions.

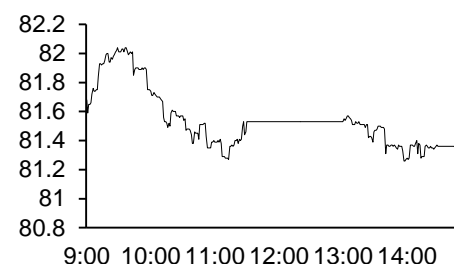
VN-Index Intraday

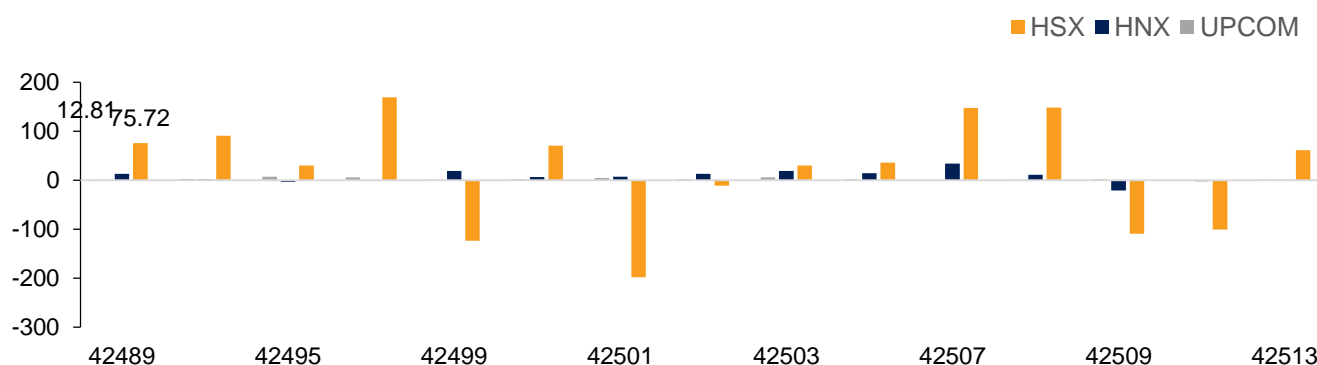
