Highlight

Today's session has plummeted after confirmation lose medium-term trend of support in the previous session. The market index has fallen deeply than 8 points, approaching the lower support at 660 points. Panorama of the market has sunk in the red for most of the correction of the stocks on the market and the majority of large-cap stocks weakened rapidly. The positive was back in the second half of the afternoon session with the rise of large stocks MWG, VIC and then the recovery of the stock of ROS, pulling back almost 7 points to the market at the end of session. Liquidity has also appeared in major process of correction of a number of large-cap stocks such as KBC, HPG, HSG, HBC, HUT, FPT today. At the close, the market recovered at 667.63 points, down 3.77 points more than the previous session. All market indices maintain the performance decline; a strong decline occurred in Smallcap stocks Largecap stocks. The positive trend is back shares of some Oil and Gas sector, but the majority of the market sector is still in effect correction.

Recommendation

Phase of scalar fluctuations ended and confirmed by the apparent decline of the entire market indices today together with the increase of value traded liquidity. As identified in our previous sessions, the market will enter a downward trend and the risk can be increased again before the ambiguity of the trend, as well as trading psychology lasted less excitement. Investors should limit disbursements during the market correction in the lower price ranges because not exclude the possibility that the decline might also take place in the short-term support level of 660 points, or lower zone at 650 points, waiting for a clear price recovery of large stocks, as well as the recovery in prices of some key sectors.

Market highlights

Today's session has plummeted after confirmation lose medium-term trend of support in the previous session. The market index has fallen deeply than 8 points, approaching the lower support at 660 points. Panorama of the market has sunk in the red for most of the correction of the stocks on the market and the majority of large-cap stocks weakened rapidly. The positive was back in the second half of the afternoon session with the rise of large stocks MWG, VIC and then the recovery of the stock of ROS, pulling back almost 7 points to the market at the end of session. Liquidity has also appeared in major process of correction of a number of large-cap stocks such as KBC, HPG, HSG, HBC, HUT, FPT today. At the close, the market recovered at 667.63 points, down 3.77 points more than the previous session. All market indices maintain the performance decline; a strong decline occurred in Smallcap stocks Largecap stocks. The positive trend is back shares of some Oil and Gas sector, but the majority of the market sector is still in effect correction.

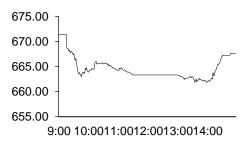
16/20 market sectors declined today, while the biggest drop occurring in sectors Plastic, Technology, Construction and Banking stocks. The market size continued to go negative, with 306 stocks fell while only 126 stocks rose on both exchanges. Foreigners were net buyers 89.65 billion Dong on the HOSE and were net sellers 13.42 billion Dong on the HNX today, a positive sign again after the Fed continues to delay raising interest rates after the end of session two days.

Recommendations

The market took upward trend in the medium term; the selling pressure on the market today has affected most of the stocks traded on the market. The VN-Index had advanced close to the support at 660 points and recovered as selling pressure decline and the market demand for forming a large number of stocks, such as MWG, VIC, ROS. However, where from the time of the week, the market has lost 14.62 points, down 2.14% compared to the previous week's closing.

Technical indicators continued deep and rapid decline, in the oversold area. MACD (12.26) has cut back below 0, established downtrend of the market in the coming sessions. The market is located in the area of risk and volatility may continue to reach the lower level of support.

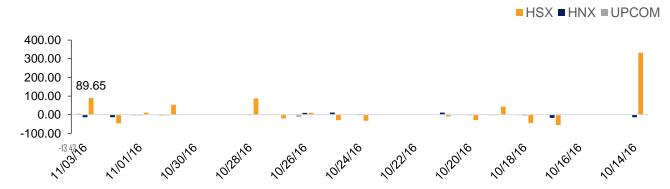
