Without taking the contribution of the score of the SAB, the market index is also in effect of correction today. Market movements continuous fluctuation in the session due to the price movement of VNM, when this stock weakened rapidly in the early morning, continued to fall in early afternoon trading and appeared rejoin from support of demand at the end of the session. Deep correction that VNM fell by 2.4% in price loses the support level of 130, closing at 127.6 points ahead of selling pressure from foreign investors for nearly 60% of trading volume today.

Recommendation

Market information is not much impact on today's trading session, index volatility and liquidity of the market is almost no change compared with the previous session; on the other hand only affect the movement of the small group of individual stocks. Market size was positive as well kept as stocks rallied still more dominant. The cash flow in the short term the market is still looking for a few specific sectors in the session, when most stocks were corrected to the price more attractive and tend to recover. The caution in trading activity is necessary for investors to pressure the structure of the two ETFs in the last session, may also require the market to test the support level of 660 points.

Market highlights

The last results of the Fed meeting this year did not greatly affect the dynamics of the market transactions. US stock markets yesterday and Asian markets today also affected by the correction, in which the S & P 500 (-0.81%), Shanghai Composite (-0.73%), Hang Seng (-1.77%), the Nikkei rose + light green holding 0.10%. Without taking the contribution of the score of the SAB, the market index is also in effect of correction today. Market movements continuous fluctuation in the session due to the price movement of VNM, when this stock weakened rapidly in the early morning, continued to fall in early afternoon trading and appeared rejoin from support of demand at the end of the session. Deep correction that VNM fell by 2.4% in price loses the support level of 130, closing at 127.6 points ahead of selling pressure from foreign investors for nearly 60% of trading volume today.

In trend leveled off after strong gains yesterday, the money flow is going on the market segmentation of sectors, including sectors such as steel, real estate, Plastics, Construction fell, some stocks in the Coal industry (TC6, THT), most stocks in Rubber sector, stocks in Sugar sector (SBT, BHS) or spikes in prices and volumes of REE (+ 5.0%) to obtain the interest. Differentiations also happen to the shares in the group as well as Beer, Real Estate, Banking, and Steel industry.

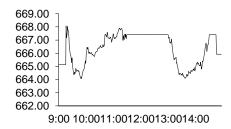
Market liquidity is almost equivalent to the previous session, trading in both value and deal value, but more than 50% of the market value of just focusing on the top 10 shares of VNM, ROS, SAB, HPG, DAH, HSG, HID, SBT, DST, REE.

Foreigners were net sellers in volume and value on HOSE, sold VNM, VIC, STB and make buying for SAB, VCB, net buyers on the HNX and UPCOM. Foreigners remained net buyers of ACV as of the present time.

Recommendations

In terms of numbers the market is moving quite close to the 670 resistance area and maintain the recovery trend from the bottom 650, however, is moving in the averages between average lines in short- term and medium- term MA (15), MA (45) quite sensitive. Technical indicators maintain active status through market index kept rising rhythm; movement in the market is also safer in today's trading session.

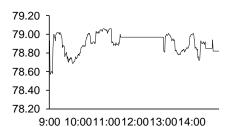

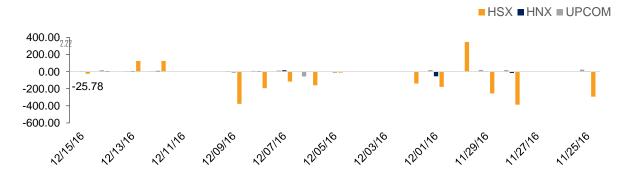
