

STOCK MARKET

The VN-Index climbed to the 1,270 level during the morning session before being pushed down by profit-taking pressure, closing at 1,264.9, up nearly 6 points compared to yesterday. Market breadth leaned positive, with 12 out of 18 sectors gaining, led by the Tourism & Entertainment sector, followed by Retail and Financial Services. Regarding foreign transactions, foreign investors were net buyers on both the HSX and HNX exchanges today. In the upcoming sessions, in a positive scenario, the VN-Index is expected to accumulate around the 1,265 level to build momentum for a breakout.

FUTURES CONTRACTS

All futures contracts increased according to the movement of VN30.

COVERED WARRANTS

During the trading session on 18/09/2024, warrants fluctuated according to the downtrend of the underlying stocks.

- Foreign investors' net buying value: VND **313.19** billion on HOSE, including **SSI (VND 137.40 billion)**, **FUESSVFL (VND 115.49 billion)**, **FPT (VND 104.35 billion)**, **TCB (VND 55.17 billion)**, **TPB (VND 52.43 billion)**. Foreign investors were net buyers on HNX with the value of VND 340.92 billion.

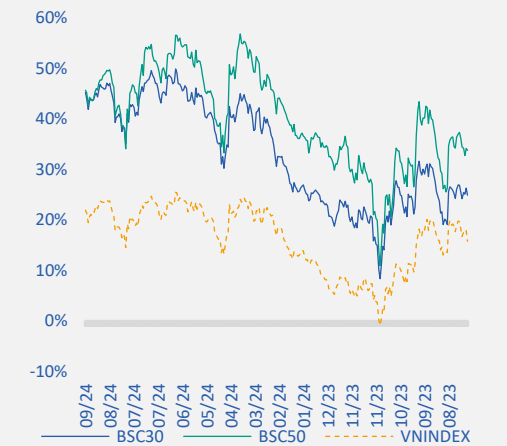

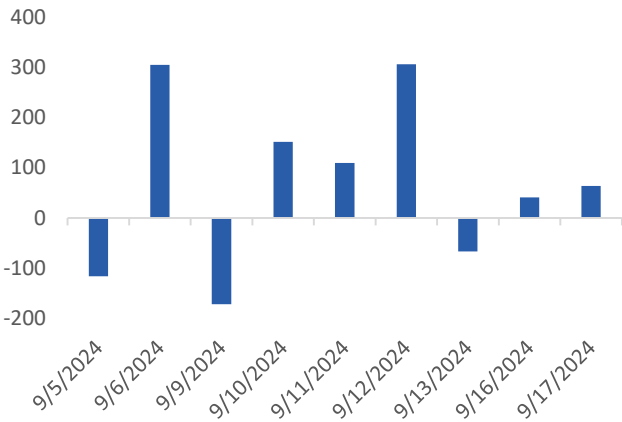

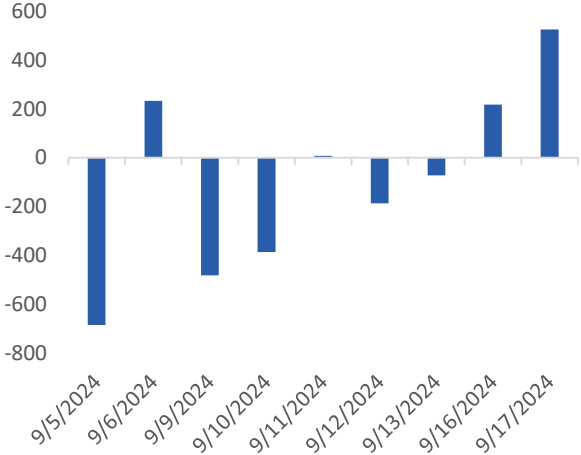
