Market outlook

Stock market: The market's upturn momentum continued in the first session of the week thanks to the active movement of Banking and Real Estate sectors. Investment cash flow decreased slightly compared to the previous session when the market had 9 out of 19 increasing sectors. Liquidity increased slightly and market breadth was neutral, reflecting the balance of buying and selling power after the market broke through the 1,200-point level. Foreigners turned to be net buyers on the HSX while net sellers on the HNX. With the return of foreign investors' net buying and stable domestic cash flow, BSC maintains the view that the market will consolidate shortly in the 1215-1230 range.

Future contracts: All future contracts increased following VN30. Investors might consider buying for long-term contracts.

Covered warrants: In the trading session on April 5, 2021, majority of coverred warrants increased following underlying securities. Trading value increased.

- The fluctuation range is 16.32 points. There were 226 gainers, 62 unchanged and 201 losers.
- Foreign investors' net buying value: 122.98 billion dong on HOSE, including MSN (VND 126.5 billion), E1VFVN30 (VND 85.8 billion) and HPG (VND 76.6 billion). Foreigners were net sellers on the HNX with the value of VND -19.25 billion.

Technical Analysis VCB_Positive Signal

Technical highlights:

- Current trend: Consolidating.
- MACD trend indicator: MACD line is above Signal line.
- RSI indicator: Ascending above 50 but has not reached the overbought zone.
- MAs line: Appear Golden Cross.

Outlook: VCB is in a status of rebounding after a short-term correction for more than a month. The stock liquidity in recent sessions has tended to increase gradually. Trend indicators are in a positive status. The EMA12 has just crossed above the EMA26 and the RSI has not entered the overbought zone, so this stock has the potential to maintain its uptrend in the short term. The nearest support of VCB is at around 100. The target to take profit of this stock is at 112.5, cut loss if 97 is penetrated.

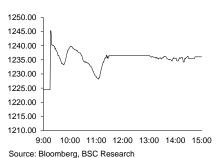

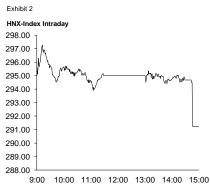

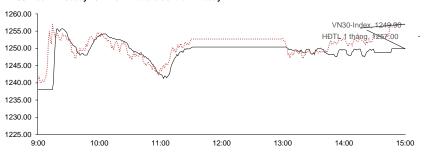

- VN30 Index increased +11.87 points to 1249.90 points. Key stocks such VCB, MBB, NVL, STB, VIC strongly impacted the increase of VN30. VN30 spent majority of trading time struggling around 1245-1255 points. VN30 might continue to rise in coming sessions.
- All future contracts increased following VN30. In terms of trading volume, all future contracts increased. In terms of open interest position, all future contracts increased. Investors might consider buying for long-term contracts.

Outlook:

- In the trading session on April 5, 2021, majority of coverred warrants increased following underlying securities. Trading value increased.
- CVIC2004 and CVRE2011 increased strongly at 10.66% and 10.00% respectively. Trading value increased by 12.12%. CSTB2014 had the most trading value, accounting for 6.10% of the market.
- CHPG2025, CFPT2017, CFPT2014, CHPG2024, and CVPB2101 have market prices closest to theoretical prices. CVPB2013, CHPG2025, and CMSN2012 were the most positive in term of profitability. CHPG2020, CHPG2014, and CVPB2015 were the most positive in term of money position.

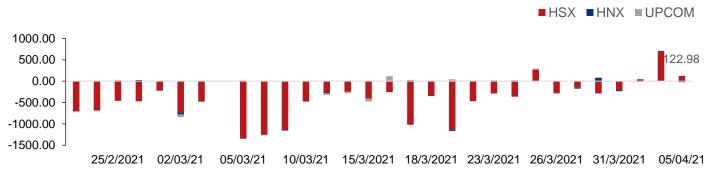
