Market outlook

Stock market: The market corrected slightly in the morning session but dropped sharply in the afternoon session. Investment cash flow continued to weaken when only 1/19 industry groups performed positively. Meanwhile, foreign investors were strong net buyers on the HSX. Market liquidity increased again and market breadth remained negative, reflecting the sell-off sentiment of investors. With the above trend, VN-Index may move in the range of 1320 -1380 points next week.

Future contracts: All future contracts decreased following VN30. Investors might consider selling for short-term contracts.

Covered warrants: In the trading session on July 9, 2021, majority of coverred warrants decreased following underlying securities. Trading value increased.

Highlights

- VN-Index -27.54 points, closed 1,347.14 points. HNX-Index -9.25 points, closed 306.73 points.
- The index pulled up: MWG (+0.52), VIB (+0.40), TCB (+0.29), DGC (+0.21), HDG(+0.08).
- Pulling the index down: GVR (-2.46), VIC (-2.32), VHM (-2.11), HPG(-2.0), NVL(-1.72).
- \bullet The matched value of VN-Index reached VND 23,457 billion, +23.30% compared to the previous session. The total transaction value reached VND 25,115 billion.
- \bullet The fluctuation range is 38.78 points. The market had 77 advancers, 33 unchange and 306 losers.
- Foreign investors' net buying value: VND 785.85 billion on HOSE, including MBB (VND 378 billion), HPG (VND 180.2 billion) and VHM (VND 77.4 billion). Foreign investors were net buyers on HNX with a value of VND 7.5 billion.

Technical Analysis ITD_Breakout

Technical highlights:

- Current trend: Rising.

- MAs line: EMA12 is above EMA26.

Outlook: ITD is in a status of continuing to increase from the beginning of the year so far. Stock liquidity in recent sessions has remained stable in value. The trend indicators are currently in a positive status. The RSI is in the overbought zone, so this stock may have a correction in the short term. ITD's nearest support is around 17. The stock's profit taking target is at 20.25, stop loss if 15.25 is penetrated.







Outlook:

- VN30 Index decreased strongly -26.78 points to 1494.43 points. Key stocks such as HPG, NVL, STB, VNM, VIC strongly impacted the decrease of VN30. VN30 spent majority of trading time in the morning sessiong struggling around 1510-1520 points, before plummeting in the afternoon session to around 1490 points. VN30 might accumulate in coming sessions.
- All future contracts decreased following VN30. In terms of trading volume, except for VN30F2107, all future contracts increased. In terms of open interest position, except for VN30F2109, all future contracts increased. Investors might consider selling for short-term contracts.
