Market outlook

Stock market: The VN-Index fluctuated in a range of nearly 18 points throughout the day. The index dropped sharply at the opening, then turned around to go up in the second half of the morning session. In the afternoon session, the buying power seemed to disappear, the index was pushed down and closed at the lowest level of the day - the support level around 1350. Real estate, construction, Securities, Banking,... dropped sharply. Market breadth tilted to the negative side with 6/19 sectors gaining. Today is the profit taking session after the previous rally. In the coming sessions, the market is likely to still accumulate around 1350.

Future contracts: Futures contracts decrease in line with the movement of the VN30 index. Investors may consider opening a long position when VN30 returns to the range of 1350-1360 points.

Covered warrants: In the trading session on May 4, 2022, warrants decreased according to the movement of the underlying stock.

Technical Analysis (Page 2): POW_Recovery signal

Highlights:

- VN-Index -18.12 points, closing at 1348.68 points. HNX-Index -4.86 points, closing at 360.97 points.
- Pulling the index up: GAS (+0.99), POW (+0.57), HVN (+0.32), SHB (+0.28), VCG (+0.25).
- Pulling the index down: TCB (-1.71), HPG (-1.44), VCB (-1.19), MSN (-1.02), VPB (-0.99).
- The matched value of VN-Index reached VND 13.491 billion, down 12.51% compared to the previous session. The total transaction value reached VND 14.455 billion.
- \bullet The trading range is 17.71 points. The market had 140 advancers, 38 reference stocks and 301 losers.
- Foreign investors' net selling value: VND -304.38 billion on HOSE, including KDH (VND -46.00 billion), DGC (VND -29.76 billion), VHC (VND -22.21 billion). Foreign investors were net buyers on HNX with the value of VND 26.07 billion.

Outlook: POW had a good rally with the almost perfect Marubozu candlestick pattern. The stock's liquidity exceeded the 20-day average. The MACD is currently below the signal line, however, there is a positive signal, the RSI is showing a recovering trend. The stock price line is below MA(20), MA(50) and MA(100) but showing positive signal. Mid-term investors can open a position at 14.05, take profit at 16.6 and cut losses if the stock falls below 12.5.



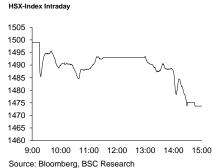

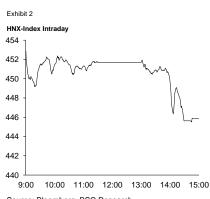

VN30-Index Intradday vs 1 month Future contrat Intraday

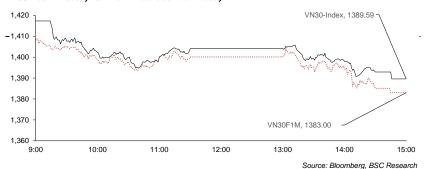

Outlook:

- VN30 dropped -27.72 points to 1389.59 points. The current movement still shows panic in the market. VN30 is likely to continue to accumulate in the range of 1350 -1400 points.
- Futures contracts decreased according to the movement of the VN30 index. In terms of trading volume, all contracts decreased, only VN30F2216 increased slightly. In terms of open positions, contracts dropped simultaneously. The declining score and the decrease in open interest are showing the trend of cash outflow from the market. Investors may consider opening a long position when VN30 returns to the range of 1350-1360 points.

Outlook:

- In the trading session on May 4, 2022, warrants decreased according to the movement of the underlying stock.
- CACB2102 and CVRE2113 had the best growth, 87.68% and 42.86% respectively. Transaction value decreased -16.25%. CVRE2113 has the most transaction value, accounting for 14.05% of the market.
- CMWG2201, CPOW2202, CPNJ2201, and CSTB2201 are warrants whose value is closest to the theoretical price. CVRE2201, CVNM2202, CKDH2204, and CVPB2204 are the most positive warrants in terms of returns. CMWG2201, CFPT2202, and CPNJ2201 are the most positive warrants in terms of money position.

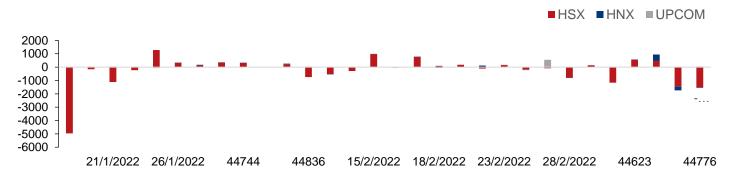
